# **CHANGE MAKER**

A Change Maker is an individual who makes a commitment to raise a minimum of INR 75,000 for his/her chosen charity/cause using the TSK25 2022 vehicle. Individuals with a wide social network or individuals who work or have seen the work of your organization can become 'Change Makers'. Young adults too can be excellent ambassadors for your work and thereby effective fundraisers as Change Makers. To register as a Change Maker, one needs to fill in and sign the registration form, which can be downloaded from marathon.uwkolkata.org . A Change Maker can register to participate in any of the race categories on race day. A Change Maker is not required to pay an additional amount as Event entry fees; this will be taken care of by the Philanthropy Partner. Race categories and event entry fees are mentioned on page 7 of this note.

REGISTRATION & FUNDRAISING PROCESS FOR A CHANGE MAKER
□ To register as a Change Maker, an individual needs to – o Fill the Change Maker Registration form o Choose the NGO/charity on wishes to fundraise for
o Submit the form along with the cheque to UWK.
☐ The management donation of UWK (i.e. INR 5000) must be paid by the NGO to UWK.
□ Once these documents and payment are received from the Change Maker/NGO, UWK will create a fundraising page and provide access of such page to the Change Maker and NGO. The Change Maker can now appeal to his/her network database and starting fundraising for the chosen NGO.
□ All funds raised will be in the name of 'United Way Kolkata', specifying the benefitting NGO, and submitted at the UWK office. UWK will in turn deduct its management donation, as mentioned in this document, and disburse the balance donation to the respective NGO.
☐ All individual fundraisers will need to submit documents as may be required by Income Tax Rules/KYC.
☐ To be confirmed as a Change Maker, the individual must have raised a minimum of INR 75,000 on or before 10th December 2022. Where an individual does not raise the minimum required amount, such person will not be entitled to the privileges of a Change

Maker; however will be entitled to participate in the Event as a normal runner. Please note UWK shall retain its management

Individuals with a wide social network or individuals who work or have seen the work of your organization can become 'Change Leaders'. Young adults too can be excellent ambassadors for your work and thereby effective fundraisers as Change Leaders. To register as a Change Leader, an individual needs to fill in and sign the registration form, which can be downloaded from marathon.uwkolkata.org. A Change Leader can register to participate in any of the race categories on race day. A Change Leader is not required to pay an additional amount as Event entry fees; this will be taken care of by the Philanthropy Partner. o Submit the form along with the cheque to UWK.
$\square$ The management donations of UWK (i.e. INR 7,000) must be paid by the NGO to UWK.
☐ Once these documents and payment are received from the Change Leader/NGO, UWK will create a fundraising page and provide access to such pages to the Change Leader and NGO. The Change Leader can now appeal to his/her network database and start fundraising for the chosen NGO.
